

# **INSTRUCTIONS FOR COMPLETING 2003 SUMMER SCHOOL LOAN APPLICATION**

**Undergraduates must enroll in at least SIX hours to be eligible for a summer school loan.**

If your credit hours change, your loan eligibility may be affected. Notify the Financial Aid Office *immediately* when you anticipate a change to any of the information on this form.

**The deadline for returning this form to the Financial Aid Office is May 1.**

Keep a copy of the form for your own records.

## **ENTRANCE COUNSELING:**

If you have never had a Federal Stafford Loan while at High Point University, you must complete entrance counseling. This is a federal regulation. Your loan **cannot** be disbursed until you have completed entrance counseling at:
