The following courses are required for a minor in criminal justice. CRJ 1900 (Introduction to the Justice System). Students will choose two of the following three options (the third option has two choices for students). CRJ 2800 (Police Operations), CRJ 3200 (Courts and Trials), and CRJ 4200 (Institutional Corrections, proposed change to 2400) OR CRJ 4500 (Probation, Parole, and Community Corrections, proposed change to CRJ 2450 - Community Corrections). Students will take two electives in CRJ to complete their minor requirements.

Rationale for Proposed Curriculum

We are adding CRJ 2800 (Police Operations) to the options of required courses for the minor. It is an important part of the criminal justice system that students should be exposed to. See proposal attached below.
