B - Course Revision Form V. 7.2022 : Entry # 3355

The course is being revised to provide ongoing production experiences for media production students. We felt that repetition of the course over multiple semesters was more beneficial than a higher number of credits with restrictions on the number of times the course could be repeated. The required external hours for a 2 credit class is 90 per term, which is more difficult for students to complete. By reducing the course to 1-credit, students now need to complete 45 hours of production activities, which we felt was more feasible.
