As a department we continue to increase rigor and an emphasis on professionalism through our course and production work. Adding THE 2150: Intermediate Theater Practicum gives us additional learning outcomes and opportunities for students to demonstrate higher level production skills through rehearsal/performance experiences, design and production work, and to build on the foundations of the performing arts established through out THE 1100 Theater Practicum course work. All THE 2150 students are required to maintain their own hours. All students are required to have a total of 60 hours per semester, total. The area supervisor will sign off on all time sheets. HPU Scene Shop & Work Call Safety Rules and Guidelines

These guidelines are issued for your safety and the safety of those around you. Strict adherence to safety and attire protocols is required for all shop hours and work calls. If you fail to follow these rules, you will be sent home and receive an absence for the day.

Shop Safety and Attire: Your safety is of the highest concern in this class. The tools and equipment we will work with, if misused, can potentially cause serious injury or death. For these reasons the following rules and regulations will be strictly enforced:

- Wear closed-toe, low-heel shoes: no open-toed shoes, sandals, flip-flops, high-heels, etc. will be permitted in the shop at any time. Sneakers and tennis shoes are okay.
- No loose-hanging jewelry: this includes necklaces, bracelets, earrings or any other jewelry that could potentially be caught in a tool or moving machinery.
- Long hair must be tied up and away from the face.
- Eye protection must be worn at all times when working with or around any tools: this will be provided for you.
- Wear appropriate clothing: at any time in the shop, we may deal with materials or situations that can dirty your clothes. DO NOT wear clothes that you mind getting dirty! You will not be allowed to go home and change. You will be excused from class and counted absent.
- No iPods, cell phones, headphones, etc.: To maintain a safe environment, you must be aware and able to hear your surroundings. Cell phones must be put away or turned off during class and any music devices must remain in your backpack.
- Medications: It is your responsibility to inform the instructor if you are taking any medications which would impair your ability to operate any machinery or tools or otherwise impair your ability to act in a safe and reasonable manner.
- Do not work alone: While most projects will be completed during class time under supervision, if the need arises to work outside of class, you must work with at least one other person in the shop and an approved supervisor present.

McInnis Dance Studio and The Empty Space Theatre Rules

- NO chewing gum
- Do not bring food and drinks into the studio or theatre (water is ok)
- Never wear street shoes in the studio
- Respect the personal space of others
- Pick up after yourself (personal belongings and trash)
- If you need to use the space you must reserve it

Costume Shop Rules

- Food and drink may not be consumed within the costume shop. You may eat snacks or drink in the kitchen area or outside. This includes water.
- Be respectful of others and the space.
- Be on time and prepared for work.
- There will be a 5-10 minute call at the end of all work periods to remind students to clean up their work space. Projects must be stored neatly in the appropriate bins, notions and materials put back where they came from, and trash/scrap must be removed from all work areas.
- Lockers must be utilized for personal belongings. All personal items must be taken at the end of the day.
- Costumes are not to leave the costume shop/dressing rooms/stage area under any circumstances.
- Costumes should be respected and those we pull from storage will need to be returned to their appropriate places.
- If you are the last to use an iron when the work day is over, please turn it off, close the gravity flow from the water container, and unplug the iron from the wall.
- Shoes must be worn at all times while in the costume shop. We highly recommend a pair of closed-toed shoes for work.

Electrics Shop Rules

- NO FOOD OR DRINKS AROUND LIGHTING AND SOUND CONSOLES!!!!!!!
- CLOSE-TOED SHOES AT ALL TIMES WHEN WORKING ONSTAGE!!
- You may only drive the scissor lift once you have been approved by faculty. Then, you may only drive the lift under the supervision of faculty
- No food or drink onstage (other than water bottles).
- No texting during work calls, unless it is HPU academic related, and has been approved by Jason Irons.
- Use common sense, ask questions, pay attention. Have fun!
