

Affidavit of Financial Support

For International Students and Scholars

High Point University is required by U.S. federal law to verify that sufficient financial resources are available to support a nonimmigrant student or scholar for the duration of their intended program of study in the United States. Before the university can issue either the Form I-20, "Certificate of Eligibility for Nonimmigrant Student Status," to an international student (F-1/F-2 visa applicant) or Form DS-2019, "Certificate of Eligibility for Exchange Visitor (J-1/J-2) Status," to an exchange visitor (J-1/J-2 visa applicant), the prospective student or scholar must provide documentation showing adequate financial support. The affidavit of financial support helps High Point University comply with these federal regulations.

An affidavit of financial support is a legal document used to confirm that someone (the "sponsor") will provide financial assistance to another person (the "applicant") while they are studying or living in a different country. When accompanying official financial support documents, this affidavit helps prove that the applicant will have the necessary funds to cover living expenses, tuition, and other costs during their stay.

Please read all parts of this form carefully to understand what is required. This form can be copied and used for multiple sponsors, if needed. If you have questions or need assistance, contact High Point University's Office of Global Education or seek legal advice.
