

Kelli's Corner with Faith Price

As the time for our first graduating class to complete the program draws nearer, I wanted to reach out to one of our students to see what they think of the MHA program. Student and HPU Women's basketball player, Faith Price shares her thoughts here.

What motivated you to pursue a master's in health administration, and how has your perspective on healthcare management evolved during the program?

I've always had passion for the healthcare industry, a desire to make a positive impact on patient care and outcomes, and an interest in the business aspect of healthcare management. I have gained a deeper understanding of the complexities and challenges within the healthcare system, including issues such as quality improvement, patient safety, how to improve healthcare technology and more.

Can you discuss a specific project or coursework from your MHA program that you found particularly challenging or rewarding?

Looking back on my experience, the program has effectively fostered a sense of community and collaboration amongst us students. Even though this program is 100% online, you still interact with each other just as much as you would in a classroom setting. Each class has weekly discussions which allows us to share our thoughts about different topics we learn about each week, and then we are also given the opportunity to respond and collaborate with other classmates.
