Competency Assessments

MHA focuses on 2-3 primary competencies taught in each course based on the competency rating scale. All faculty will be required to rate the students on the competency scale below. In addition, each student will complete a self-assessment of their competency on the assignment. The results of this assessment will be used to improve student performance in the program. The following scale is used to rate each student at the end of each term:

1. **Advanced Knowledge/Exceeds Expectations:** The student has advanced knowledge and proficiency about the topic that is more specialized and integrates all course topics. (90-100%)
2. **Competent/Meets Expectations:** The student is competent in the course topics and can teach these key topics in the workplace. (80-89.99%)
3. **Novice/Below Expectations:** The student demonstrates awareness of the course topic, explains the topic, and appreciates the value of the topic, and can explain it to the faculty member. We recognize that a novice score will occur more often early during the MHA program. (70-79.99%)
