
# **CITI Training**

- 1. You must have <u>current</u> human subjects training via CITI before submitting a protocol. Faculty and staff training is valid for 3 years; student training is valid for 1 year.
  - a. First-time applicants must register with CITI and complete training. Go to citiprogram.org. Select the Register option on the top right.



b. Affiliate with the University by typing High Point University on the next screen and Agree to the Terms of Service and Privacy Policy. Then Continue.



- c. Answer the next several pages of questions (name, email address, etc.) to complete your registration. You will need the email address and password you create to login to your CITI account in the future.
- d. You will be asked several questions about the type of training you need to complete.
  - Question 1 Everyone will choose an option. The most common are Biomedical (i.e., health sciences, biology, exercise science) or Social and Behavioral (i.e., psychology, education, communication, political science.).


